**MEMORANDUM**

**Subject : Implementation of the recommendations of the Sixth Central Pay Commission as accepted by the Central Government-revision of pay scale of the employees of the Corporation.**

A reference may kindly be made to the following references issued by the Ministry of Personnel, Public Grievances and Pensions:-

The above references, resolutions (may be downloaded from Govt. of India Website bearing address [www.india.gov.in](http://www.india.gov.in)) of the Govt. of India have been adopted by the ESI Corporation in its meeting held on 9<sup>th</sup> September,2008 to make it applicable to the ESI pensioners. Accordingly it is requested to take immediate necessary action for revision of pension/family pension of the ESIC pensioners.

For revision of pension of pre 2006 pensioners/family pensioner, there is no necessity for the pension disbursing authority to refer the case to the HQ Office for revision of pension. The pension disbursing authority i.e. the field unit should initiate suo-moto action for revision of pension and payment of arrears as per the Govt. of India Orders dated 1<sup>st</sup> September,2008. The instructions as contained in the Office Memorandum dated 1<sup>st</sup> September,2008 may be gone through carefully and pension be fixed and arrears disbursed at the earliest.

In the case of post 2006 pensioners/family pensioner i.e. pensioner who retired/retire on or after 1.1.2006, the Field Unit should submit the revised pension proposal based on the instructions of the Govt. of India circulated vide letter dated 2<sup>nd</sup> September,2008 to the Accounts Branch-IV (HQ) for issue of revised PPO. Accordingly they are advised to obtain the option letter from the Govt. of Servant in terms of Rule 5 of Central Civil Services (Revised Pay) Rules 2006 and action may be taken to process their case expeditiously. Arrears, difference in pension, commutation, gratuity etc. shall be payable to them after getting HQ Office specific sanction.
