CIRCULAR

Subject:- Payment of pension consequent to the decision on the recommendations of 6th Central Pay Commission

- 1 Pensionary benefits etc. to be paid during this financial year for all categories shall be (i) Pension arrears at 40% (ii) Commutation at 100% and (iii) DCRG at 100%.
2. According to para 11 of the OM No.F.38/37/08-P&PW (A) dated 1-9-2008 read with para 4 of OM dated 14-10-2008, the following action is to be taken by the Corporation and pension disbursing bank in respect of pre -2006 pensioners:-
 - (i) Payment of revised pension/family pension to be made as per the revised concordance table by the pension disbursing PSBs for all pensioners and family pensioners including dearness relief as applicable from time to time.
 - (ii) PSBs to make suitable entry of the revised pension in the PPOs and intimate the revised disbursement to the ESIC.
 - (iii) ESIC to verify the revised pension, update the PPO register and acknowledge the same.
 - (iv) ESIC to provide information on the date of birth, scale of pay, qualifying service, commutation and restoration, enhanced pension etc. to the bank.

Accordingly, whenever such cases are pending for disposal, the same may be got completed soon through the bank and a compliance report sent to this office latest by 31-1-2009.

- 3 As per OM dated 2-9-2008 where pension/family pension/gratuity/commutation of pension etc. have already been sanctioned in respect of post 2006 pensioners the same may be revised immediately, if not already done, and arrears may be paid to the extent indicated herein including arrears of pay and leave encashment, if any, through revised pay bills, PPO etc. This action, if still pending, may be completed immediately and a compliance report submitted to this office latest by 31-1-2009.

It may be ensured that only pension/family pension is to be revised in respect of all those retired prior to 1-1-2006 subject to para 4 below and pay and pensionary benefits including DCRG and commutation for all those retiring on or after 1-1-2006 while the relaxed provisions of qualifying service of 10/20 years is available only to those retiring on or after 2-9-2008.

As per OM dated 1-9-2008 read with OM dated 3-10-2008 the fixation of pension shall not be made at lower than 50% of the minimum of the corresponding revised pay plus grade pay and not of the grade/post held, which will be subject to prorata reduction where the pensioner had less than the required service for full pension as per Pension Rules. A compliance report as above may be sent latest by 31-1-2009

As per para No. 11 of OM dated 1-9-2008 read with para 4 of OM dated 14-10-2008, the heads of regions etc. shall suo moto issue revised PPOs in respect of all pre and post 2006 pensioners and family pensioners after ascertaining the date of birth as per the revised format of PPO issued on 03-11-2008 and a copy endorsed to the pensioner without demanding the original PPO from the pensioner or the bank. Action as suggested maybe completed immediately, if not already over, and a compliance report sent to this office latest by 31-01-2009.

Instructions delegating power to issue PPOs by the Heads of Offices (RD/ JD Incharge/MS/D(M)D etc.) have been issued vide letter No.A-40/Misc./2008/A/cs-IV dated 3-11-2008. Accordingly pension papers relating to all kinds of pension/family pension /gratuity/commutation etc. in respect of all group C and D as well as ad hoc group 'B' officers shall be prepared, sanctioned and issued by the Head of Office after due concurrence by the Fin. & A/cs Branch. As informed the format of revised PPO enclosed with the said letter may, if required, may be suitably modified and if necessary, particulars of income tax be excluded by deleting the words "less income tax from the revised PPO.

Action as above may be completed immediately, if not already done, and compliance report sent to this office latest by 31-1-2009.
