

With reference to RTI Cell's U.O. No. 3(227)/08-RTI dated 22<sup>th</sup> October, 2008, the applicant may be informed that Note 4 under Rule 7 of the CCS(RP)Rules 2008 on fixation of initial pay in the revised pay structure states that:-

A Government servant under suspension, shall continue to draw subsistence allowance based on existing scale of pay and his pay in the revised structure will be subject to the final order on the pending disciplinary proceedings.

2. Hence, if he was suspended prior to 1.1.2006 then the above rule will apply. In case he was suspended after 1.1.2006 then his pay will be fixed as per his option under the provisions of CCS(RP) Rules, 2008.
