**C I R C U L A R**

**Sub: Delegation of power of the Director General to the SSMC/SMC in respect of certain benefits.**

In exercise of the powers vested in him, under Sub-Rule (2) of Rule 16 of ESI (Central) Rules, 1950 read with Standing Committee resolution dated 24.05.1968, the Director General has delegated his following existing powers of relaxation to the SSMCs/SMCs:-

Sl. No.	Nature of power	Existing Delegation	Revised Delegation
1.	Disability arising out of drugs & Injection	D.G., as per Corporation resolution dated 06.02.1963	SSMC or SMC, as the case may be
2.	Long term disease case i.e. T.B., Leprosy, Mental and Malignant diseases etc.	D.G., as per Corporation resolution dated 23.08.1960	SSMC or SMC, as the case may be
3.	Super Speciality Treatment Cases.	D.G., as per Standing Committee meeting held on 23.06.03	SSMC or SMC, as the case may be
4.	Time barred claims after 6 years	D.G., as per Circular dated R-11/30/02/Ins.II dated 29.04.02	Addl. Commissioner (Bft.) or Director (Bft.), as the case may be

Henceforth, all the cases noted at Sl No. 1 to 3 above should not be referred to the Hqrs. Office for relaxation by the DG, instead all the Regional & Sub Regional Heads should send it to the SSMC/SMC, as the case may be, after thorough examination at RO/SRO level.

The cases noted Sl. No. 4 above will however, continue to be sent to the AC(B)/Dir(B) Hqrs, as usual.

The above revised delegation is made by the DG to reduce to time lag and faster services to the IPs in these cases. Accordingly, all concerned officers are to ensure speedy disposal of such cases.

A quarterly report regarding the first 3 cases should be sent to the Hqrs. Office (Benefit Branch I) indicating all relevant details by 10<sup>th</sup> of the month falling due after the end of the Qtr., beginning with January 10<sup>th</sup>, 2009, as per enclosed proforma.
