Subject : **Provision of technical manpower at key locations - regarding.**

Sir/Madam,

Many of our field offices have time and again been referring the issue relating to provision of technical manpower wherein they wanted clarifications with respect to following points :

1. If there is no requirement/use of deployed manpower, whether they can surrender ?
2. What is the break-up of wages approved for the technical manpower ?

After consideration of all relevant factors it has been decided that those field offices which wish to surrender the provided manpower can do so subject to the condition that they are not able to utilize the services of such manpower.

The details with regard to wages of technical manpower is prescribed in our letter of even number dated 02-07-2008 are as follows :-
