**Subject :- Delegation of powers of the Director General to  
RDs./Directors/JD I/cs. in respect of ESB.**

Sir,

I am directed to refer to the Corporation resolution dated 5-12-1999  
circulated vide Hqrs. Memo. No.R-16/13/1/93-Ins. Dated 17-2-2000.

As per para 15 of the resolution, if the enforcement of any particular  
provision of this resolution is likely to cause substantial hardship to the Insured  
Person the Director General/Insurance Commissioner on humanitarian  
consideration can relax the same. Accordingly the field units have been  
sending the cases regarding relaxation to Hqrs. Office for relaxation thereby  
causing delay in the acceptance of the case .

To avoid delay and mitigate the hardship to the IPs , Director General  
has further delegated his power of relaxation to the RDs/ Dir./ JD I/cs. in the  
light of the Rule 16 (2) of ESI ( Central ) Rule 1950 read with Standing  
Committee Resolution dated 24.5.68.

Henceforth all cases of relaxation may be decided by RD/Dir./JD I/cs.  
and no case may be referred to Hqrs. Office for relaxation. However, speedy  
disposal of such cases may be ensured.

A quarterly report in this regard may be sent to Hqrs. Office, Benefit  
Branch-I indicating all relevant details by 10<sup>th</sup> of the month falling due after  
the end of the quarter beginning with January,2010.
