MEMORANDUM

SUB: Upgradation of 75% posts in the Cadre of LDC to the post of UDC - regarding.

Ref: OM No. A-40/11/1/2011-E.III.Col.II dated 05.09.2011 & 14.09.2011.

Attention is invited to this office Memorandum of even No. dated 14.09.2011 wherein it was requested that action on this office Memorandum of even No. dated 05.09.2011 be kept in abeyance till receipt of further communication from this office.

Consequent upon the receipt of the approval from the Ministry of Labour & Employment, Government of India, as communicated vide their letter No. A-12018/03/2011-SS.I dated 20-10-2011, for re-fixing the cut off date for placement of the LDC's in the cadre of UDC's in ESIC Corporation as on 01.12.2011 instead of 01.08.2011, necessary action may be initiated for implementing the OM of 05.09.2011 with the following changes:-

1. All the existing LDCs as on 01.12.2011, irrespective of their qualification, subject to vigilance clearance, will be placed in the posts of UDC's.
2. This upgradation will be effective from 01.12.2011.
3. In respect of the Regions, where the recruitment process for appointment as LDC's is in progress, the respective Regional Director's should ensure that the individuals selected for appointment as LDC's should not be allowed to join after 15-11-2011. The respective Regional Director's may take necessary steps to intimate the selected candidates that in no case will they be permitted to join beyond 15-11-2011.

All other terms & condition communicated vide OM of 05.09.2011 will remain unchanged.
