Please refer to this office letter of even no. dated 27/12/10 and reminder dt. 30.3.11 on the above subject.

In this connection, it is again stated that the proposals of Administrative RBEs 2010-11 & BEs 2011-12 have not been received through the ERP software developed by WIPRO except for eight ROs/SROs viz. Noida, Haryana, Assam, Vadodara, Ahmedabad, Peenya, Indore and Visakhapatnam. **The proposal have not been received from other units.**
