The Competent Authority is pleased to order promotion of Shri P. Barua in the grade of Regional Director Gr. 'B'/Joint Director to the grade of Regional Director Gr. 'A'/Director on adhoc basis in PB-3 (Rs.15600-39100) Gr. Pay of Rs.7600/- and post him as Regional Director Gr. 'A' (Adhoc) RO Assam.

The promotion of Shri P. Barua will take effect from the date of his assumption of charge to the promoted post.

The promotion of Barua is ordered purely on temporary and adhoc basis. He may be reverted to his lower post without any notice or assigning any reason thereof. The adhoc promotion shall not confer on him any right to continue in the post or for regular promotion in future. The period of service rendered by him on adhoc basis in the grade/cadre will count neither for seniority in the grade/cadre nor for eligibility for promotion to the next higher grade. The pay on promotion will be fixed in the Pay Band of PB-3 (Rs.15600-39100) with grade pay of Rs.7600/- under the normal rules.

The promotion order of Shri Barua will be subject to the final outcome of WP(C) No.6301 of 2001, WP(C)No.5433 of 2006 pending before the Hon'ble High Court of Delhi and WP No. 13374/2010 pending before Hon'ble High Court of Madras.

The officer will immediately take relief from the present post to take charge as Regional Director Gr. 'A' (Adhoc) RO Assam.
