The respective controlling officer shall ensure that the Medical Officer being promoted have rendered 5 years of service as IMO Gr. I on the approved date of promotion after excluding the period of EOL availed, other than on Medical Grounds / Study purpose by him / her during her service tenure., while allowing higher scale.

In the event of a Medical Officer who is promoted being on regular leave / study leave / deputation / foreign assignment etc., the promotion will take effect from the date he / she assumes charge of the post on completion of regular leave / study leave / deputation etc. In such cases information may be sent to this office.

The pay of the above officials on promotion shall be fixed under Rule 13 (1) of Revised Pay Rules, 2008 and they will have the option, to be exercised within one month from the date of issue of this order for fixation of their pay in the new post with effect from the date of increment in the old post.

The promotion will be subject to such terms and conditions as laid down in ESI Corporation (Staff & Conditions of service) Regulations, 1959 as amended from time to time.
