**OFFICE ORDER NO. 460 OF 2010**

In pursuance of the recommendations of the Departmental Promotion Committee which met on 11<sup>th</sup> November, 2010 to assess the deferred cases of earlier DPC which met on 19<sup>th</sup> March, 2010, the Director General has allowed the promotion to Dr. Satish Bala Arora, NFSG in the Grade of SAG in Pay Band – 4 with Grade Pay of Rs.10,000/- on regular basis with effect from 1<sup>st</sup> April, 2009.

**The controlling officer may please ensure that even after excluding the period of EOL availed, other than on Medical Grounds / Study purpose by her during her service tenure, she should have completed 20 years of service as on approved date of promotion while allowing higher scale.**

In the event of a Medical Officer who is being promoted in the higher scale being on regular leave / study leave / deputation / foreign assignment etc. on the recommended date of promotion, the promotion will take effect from the date she assumes charge of the post on completion of regular leave / study leave / deputation etc.

The pay of the above official on promotion shall be fixed under Rule 13(1) of Revised Pay Rules, 2008. However, she will have the option, to be exercised within one month from the date of issue of this order for fixation of her pay in the new post with effect from the date of increment in the old post.

The placement will be subject to such terms and conditions as laid down in ESI Corporation (Staff & Conditions of service) Regulations, 1959 as amended from time to time.

She will be placed below Dr. Umesh Kumar Jain and above Dr. Chitra Mehta in the seniority list.
