Further, the cases of the officials holding higher posts on purely adhoc basis before the date of recommendation of financial upgradation, if any, may be regulated as per point No. 26 of Annexure-I of DOPT OM dated 19-05-09.

Their pay on up gradation shall be fixed as per para 4, & 7 of annexure-I to the aforesaid O.M dated 19-05-2009. Before allowing the financial up gradation as per the details above, the R.D/J.D In charge may verify the detail of each individual case from the service records of the officer concerned. Discrepancy, if any, may be immediately brought to the notice of Hqrs. Office.
