(A) Educational & Other Technical Qualification, Age for the various posts:-

(1) Jr. Radiographer

Essential

(a) Matriculation or equivalent from a recognized Board. Diploma or certificate in Radiography of a Recognized Institute.

(b) Age 20-25 years.

(2) O.T. Asstt.

Essential

(a) Matriculation or equivalent qualification from a Recognized Board. O.T. Assistant Training or one year experience in the field.

(b) Age not exceeding 25 years. (Relaxable up to 35 years in case of Govt. servant and employees of the ESIC)

(3) Lab. Assistant

Essential

(a) Matriculation or equivalent qualification from a recognized Board with Diploma in Medical Laboratory Technology.

(b) Age not exceeding 25 years. (Relaxable up to 35 years in case of Govt. servant and employees of the ESIC)

(4) Pharmacist (Allopathic)

a. Educational & Other qualification:- Degree in Pharmacy **OR** Matriculation or equivalent qualification from a recognized board and qualified and registered compounder / pharmacist.

b. Not exceeding 25 years. (Relaxable up to 35 years in case of Govt. servant and employees of the ESIC)

(5) **ECG Tech.**

Essential

- (a) i) Science Graduate preferable with one year experience of handling E.C.G. Machine.
ii) Matric or equivalent qualification from a recognized Board with one year's experience of handling E.C.G. Machine.
- (b) Age not exceeding 30 years. (Relaxable up to 35 years in case of Govt. servant and employees of the ESIC)

Relaxation in age to SC/ST OBC / PH/ Ex. Servicemen and other categories shall be allowed as per instructions of Govt. of India.

B Fee & Mode of Payment:

Application of Rs.75/- (Rupees Seventy five only) is payable by Genl. & OBC candidates.

Note:-

- (a) Candidates belonging to SC/ ST/ PH/ Ex. Servicemen are exempted from the payment of above fee. Departmental candidates are exempted from payment subject to enclosing certificate of service from the ESI Hospital / Dispensary.
- (b) The fee is required to be paid by all the candidates through Demand Draft issued in favour of “**ESI Corporation**” payable at **State Bank of India, New Delhi**.
- (c) The Demand Draft may be drawn on or after the date of publication of advertisement, payment in any other form will not be accepted.

(C) Date of Examination & Examination centre – Written examination (Screening test for short listing of candidates) and / or interview shall be held in Patna. However, the Corporation reserves the right to change the examination / interview centre. Written examination will be held on 12-07-2009 (Sunday).

(D) Instructions to candidates – how to apply:-

1. The crucial date for reckoning the age will be the last date of receipt of applications i.e. **22-06-2009**.
2. The application in the prescribed proforma given below duly filled in English or Hindi language, duly supported with clear / legible attested copies of the relevant certificates and marks statements (in English or Hindi) should be sent by Registered post / Speed post to at the following address :-

3. Candidates have to fill in the application form in their own handwriting with blue or black ball point pen.
4. Original documents / certificates should not be sent with application.
5. The candidate should submit one application only in an envelope. The candidature of those candidates who submit more than one application is liable to be rejected.
6. Envelope containing the application should be super scribed “Application for the post of _____”. One envelope should contain one application only.
7. The Corporation reserves the right to call candidates for written examination or interview or both.

8. Application not in the prescribed proforma as appended below **OR** incomplete (without photograph also) applications **OR** unsigned applications **OR** applications received after the last date of the receipt of applications **OR** without required enclosures are liable to be rejected and no reason of rejection will be communicated.
9. The applications not in accordance with the above mentioned instructions are liable to be rejected.
10. The candidates already in Govt. Service must specifically mention the details of employment and should submit their application **through Proper Channel**. However, they may send an advance copy of their application alongwith Demand Draft, other certificates and testimonial so as to reach this office on or before the last stipulated date for receipt of application.
11. Mere submission of application does not confer any right on the candidates to be called for examination or interview.
12. No interim correspondence / enquiry will be entertained.
13. Last date of receipt of application is **22-06-2009** up to 5.30 P.M. ESI Corporation will not be responsible for postal delays. In respect of candidates residing in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh division of Jammu & Kashmir State, Lahul & Spiti district and Pangti sub division of Chamba district of Himachal Pradesh, Andaman & Nicobar Islands or Lakshadweep, the last date for receipt of applications is **29-06-2009**. The benefit of extended time will be available only in respect of applications received by post from the above mentioned areas/regions.
14. No TA shall be payable to any candidate including SC/ST candidates for appearing in the written examination. However, TA shall be paid to SC/ST candidates for appearing in interview as per Govt. of India orders.
15. Documents required to be attached with the application.
 - i) Attested copies of certificates in support of 1) Date of birth 2) Educational & Technical qualification alongwith marks statement 3) caste / community certificate 4) Discharge certificate in respect of Ex. Servicemen. 5) Disability certificate in respect of PH candidates
 - ii) Two recent passport size photograph duly attested by Gazetted officer. One photo should be firmly pasted (Not stapled or pinned) in the space provided in the application form.
 - iii) Demand Draft.

Note:-

1. The Demand Draft should not be tagged or stapled, but should be pinned or clipped at the top of the application form.
2. Fee once paid will not be refunded under any circumstances.
3. Candidates must write his / her name, address and post applied on the back of the Demand Draft.
4. In case of any discrepancy in English / Hindi version of the advertisement, English version will be treated as final.
