01. Essential:-

a) Qualification:-

1. A recognized medical qualification included in the first or second Schedule or Part-II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of educational qualification included in Part-II of the Third Schedule should also fulfill the conditions stipulated in Sub-Section (3) of the Section 13 of the Indian Medical Council Act, 1956.
2. Post Graduate Degree in the concerned speciality as mentioned in Annexure-I or equivalent.
3. M.Ch. for Surgical Super Specialities and D.M. for Medical Super Specialities of (2/3 years duration or 5/6 years {integrated} recognized course or qualification.

b) Experience:-

Eleven years experience in recognized institution in the subject of Speciality after obtaining the degree of M.Ch. / D.M. of five years duration in the respective discipline / subject.

OR

Ten years experience in recognized institution in the subject of Speciality for the candidates possessing 06 years recognized degree of D.M. / M.Ch. in the respective discipline / subject.

HOW TO APPLY:

(A) Applicants may apply in the form appended below. Application complete in all respects and enclosing attested copies of all essential certificates in a cover superscribed "Application for the post of _____" by Registered Post/Speed Post so as to reach the office of **Senior State Medical Commissioner, E.S.I. Corporation, Regional Office, 5-9-31/1/B, Opp. Old Gandhi Medical College, Basheerbagh Main Road, Hyderabad-500063** as per following instructions.

The following testimonials etc. should be attached with the application form:-

- (a) Two copies of recent passport size photographs duly attested by Group 'A'/Group 'B' Gazetted Officer, with one photograph pasted on the application form.
- (b) Attested copies of certificates and testimonials in proof of age/date of birth, educational qualifications and experience etc.
- (c) Attested copy of community/status certificate in prescribed form in case of candidates belonging to SC/ST/OBC/PH/ Ex. S.M. category. Candidates claiming reservation/age relaxation on the grounds of belonging to OBC should submit the community certificate in Annexure-'A' prescribed vide Govt. of India, Deptt. of Personnel & Training O.M. No. 36012/22/93/Estt. (SCT) dated 15-11-93 failing which the benefit of reservation or age relaxation will not be given.

Candidates employed in Govt./Semi Govt./Autonomous bodies should send their applications through proper channel. Note 1:- The application and other documents should be arranged in the following order, one below the other and tagged tightly or stappled on the left hand side top corner:

- (i) Two additional photographs.
- (ii) Application form.
- (iii) Attested copies of certificates.

Note 2:- The demand draft should not be tagged or stappled but should be pinned or clipped at the top of the application form. **The name and address of the candidate and the post applied for should be written on reverse of the demand draft.**

General Conditions:-
