1. A recognized medical qualification included in the first or second Schedule or Part-II of Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of educational qualification included in Part-II of the Third

Schedule should also fulfill the conditions stipulated in Sub-Section (3) of the Section 13 of the Indian Medical Council Act, 1956.

2. Post Graduate Degree in the concerned speciality as mentioned in Table "A" below: -
3. 5 years experience in the concerned speciality after obtaining the first Post Graduate Degree.
4. Language test: The candidate shall have passed middle level examination in official language of the State concerned where the vacancies are notified or if no candidate is available who fulfills the required conditions, Selection Board will have powers to recommend candidates who have working knowledge of local language.

HOW TO APPLY:

(A) Applicants may apply in the form appended below. Application complete in all respects and enclosing attested copies of all essential certificates in a cover superscribed "Application for the post of _____" by Registered Post/Speed Post so as to reach the office of **Senior State Medical Commissioner / State Medical Commissioner, E.S.I. Corporation, Regional Office, 5-9-31/1/B, Opp. Old Gandhi Medical College, Basheerbagh Main Road, Hyderabad-500063** as per following instructions.

The following testimonials etc. should be attached with the application form:-

- Two copies of recent passport size photographs duly attested by Group 'A'/Group 'B' Gazetted Officer, with one photograph pasted on the application form.
- Attested copies of certificates and testimonials in proof of age/date of birth, educational qualifications and experience etc.
- Attested copy of community/status certificate in prescribed form in case of candidates belonging to SC/ST/OBC/PH/ Ex. S.M. category. Candidates claiming reservation/age relaxation on the grounds of belonging to OBC should submit the community certificate in Annexure-'A' prescribed vide Govt. of India, Deptt. of Personnel & Training O.M. No. 36012/22/93/Estt. (SCT) dated 15-11-93 failing which the benefit of reservation or age relaxation will not be given.
- Two self addressed envelopes of size 23 x 10 cms.

Note 1:- The application and other documents should be arranged in the following order, one below the other and tagged tightly or stapled on the left hand side top corner:

- Two additional photographs.
- Application form.
- Attested copies of certificates.
- Self addressed envelopes.

Note 2:- The demand draft should not be tagged or stapled but should be pinned or clipped at the top of the application form. **The name and address of the candidate and the post applied for should be written on reverse of the demand draft.**

General Conditions:-
