Sub: Implementation / extension of ESI Scheme in a ' New geographical areas' – Bearing of cost of medical care by ESIC in respect of North East States.

Sir/Madam,

I am directed to refer to this Office letter of even no. dt. 13.6.95 wherein approval of the Director General was conveyed for bearing entire expenditure on medical care incurred by State Govts. in respect of expansion of ESI Scheme to new geographical areas only for initial period of three years.

The position has since been reviewed by the Corporation and in order to accelerate the pace of implementation / extension of ESI Scheme to new geographical areas by the State Governments of North East region, the Corporation has taken a decision in its meeting held on 21.12.05 that the Corporation will bear the entire expenditure on medical care incurred by the State Governments of North East States in respect of implementation / extension of ESI Scheme to new geographical areas only for an initial period of five years instead of three years ( as earlier decided in the Corporation's meeting held on 19.12.1989) subject to the condition that a separate account of the expenditure is maintained and a certificate to that effect with the actual amount spent is submitted to the Corporation.

After a period of five years the expenditure would be shared between the Corporation and the State Governments in the usual ratio as normal expenditure on medical care as per prescribed ceiling. These instructions would be effective w.e.f. 1.4.2006.
