**ADMISSION POLICY FOR UNDER GRADUATE (MBBS/BDS) ADMISSIONS FOR  
ACADEMIC SESSION 2018-19**

(In ESIC Medical/Dental Colleges and some other State Govt. Medical Colleges)

1. ESI Corporation, a statutory body established by an Act of Parliament, i.e. ESI Act [Act No. 34] of 1948, under the administrative control of Ministry of Labour & Employment, Govt. of India, has started Medical Education Institutions in the country at large.
2. The Central Government has approved the admission policy and procedure for under graduate (MBBS/BDS) Courses in ESIC Medical Education Institutions **which provides for 'Insured Persons (IPs) Quota' after allocation to "All India Quota" and the "State Government Quota"**.
3. **'Wards of Insured persons' under ESI Scheme who meet the laid down eligibility criteria including qualifying in National Eligibility cum Entrance Test (UG)-2018 [NEET (UG) - 2018], as and when it is notified, can apply for admission to UG course (MBBS/BDS) in ESIC Medical/Dental Colleges under 'Insured Persons Quota' for academic session 2018-19.**
4. **The Admission Policy with details in this regard, is annexed. Directorate General Health Services (DGHS), GoI, had conducted the counseling for 2017-18 admissions and is likely to do so again for 2018-19.**

**5. The provisional Institution-wise details of seats to be allotted under 'Insured Persons (IPs) Quota' are as under**

\*Respective State Governments have started MBBS course at erstwhile proposed ESIC Colleges at serial No.(7) to (9) after transfer of infrastructure to set up and run the medical colleges. These colleges have to contribute seats to the 'pool' of seats for 'Insured Persons (IPs) Quota' as per terms of MoU for transfer of the infrastructure.

**6. Methodology for filling up of Insured Persons (IPs) Quota for 2018-19 - Candidates will be allotted seats, based on their 'Group' and merit cum preference of Institution, through a centralized counseling likely to be conducted by DGHS, GoI.**

**7. The critical date for determining the age of 'Ward of IP'; and for eligibility under the 'Insured Persons Quota' would be the 1<sup>st</sup> January, 2018.**

- 8. The details of (i) Groups I/II/III; and (ii) 'Specified Contribution periods' under the Groups** for eligibility under "Insured Persons (IPs) Quota" for academic session 2018-19 are listed in the Policy.
- 9. Proof regarding combined Income of IP & spouse (parents of the applicant) being Rs. 06 lakh or less for financial year (FY) 2016-17 is to be provided. *Income Certificate by 'Appropriate Authority' authorized to issue OBC Certificates, i.e.***
- ◆ District Magistrate / Additional Magistrate / 1<sup>st</sup> Class Stipendiary Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner ( not below the rank of '1<sup>st</sup> Class Stipendiary Magistrate')
  - ◆ Chief Presidency Magistrate / Additional Chief Presidency Magistrate / Presidency Magistrate
  - ◆ Revenue Officer not below rank of Tehsildar
  - ◆ Sub-Divisional Officer of the area where the candidate and/or his/her family resides.
