

- (ii) For the candidates possessing DNB qualification from MCI recognized medical colleges/central institutes where no MD/MS course running: Three years teaching experience in the subject in a recognized medical college either during the DNB course or after possessing DNB qualification. The concerned candidate would also require one year of additional teaching/research experience in the concerned subject in a recognized medical college after obtaining DNB qualification.

D. **AGE LIMIT:** Not exceeding 64 years as on last date for receipt of application forms for all posts and categories.

E. **PAY & ALLOWANCES:**

1. ESIC has adopted recommendation of 6<sup>th</sup> Central Pay Commission. Pay (Pay in pay Band plus grade pay) and other allowances shall be paid as admissible (Salary modification due to implementation of 7<sup>th</sup> CPC scale is in process).
2. The retired Government Officers shall be paid emoluments in accordance with the rules in force as on date.
3. Other candidates appointed on contractual basis will be paid Pay at the initial stage i.e. entry Pay of the relevant Pay Band plus corresponding Grade pay and other allowances as per rules of the Corporation.



The following testimonials should be attached with application form.

- Two self attested copies of recent colored passport size photographs with one photograph firmly pasted at the appropriate place on the application form.
- Self attested copies of certificates and testimonials in support of (i) Proof of age (Date of birth), (ii) Educational qualification, (iii) MCI/ DCI (For Dental Specialties) recognized teaching experience issued by the Head of Institute or Head of the Department, (iv) DCI/MCI/DMC Registration proof (v) Research publications in indexed journals, (vi) Pension payment order (PPO), in case of retired employees from govt. organizations.
- Self attested copy of Community/Status Certificate in case of candidates belonging to SC/ST/OBC category. Candidates claiming reservation/age relaxation on the grounds of belonging to OBC category should submit the valid community certificate prescribed vide Govt. of India, Department of Personnel and Training O.M. 


