MEMORANDUM

Sub: Grant of revised pay structure of grade pay of Rs.4600 in the pay band PB-2 to the posts of Insurance Inspectors/Manager Gr.II/Office Superintendent – clarification regarding fixation of pay in respect of directly recruited Insurance Inspector recruited on or after 1.1.2006.

References have been received from various regions seeking clarification regarding Fixation of pay in respect of directly recruited Insurance Inspector recruited on or after 1.1.2006 consequent upon grant of revised pay structure of grade pay of Rs.4600 in the pay band PB-2 to the posts of Insurance Inspectors/Manager Gr.II/Office Superintendent. The issue has been examined and accordingly as per Section II of the First Schedule of the Revised Pay Rules, 2008, the pay of directly recruited Insurance Inspectors recruited on or after 1.1.2006 should be fixed in the following manner:-

1. Since the Grant of grade pay of Rs.4600/- is notionally granted form 1.1.2006 and the monetary benefit has been granted only from 1-10-2007, in the case of the direct recruits also the entry pay of grade pay of Rs.4600 + 12540 as pay in the pay band totaling to Rs.17,140/- should be granted only notionally for the period from 1-1-2006 to 30-9-2007 and monetary benefit should be granted only from 1-10-2007.
2. However, in the case of Direct Recruits appointed as Insurance Inspector on or after 1.10.2007 their pay should be fixed directly at Rs.12540 as pay in the pay band with grade pay of Rs. 4600 totaling to Rs. 17,140/-.

This issues with the concurrence of Finance & Accounts.
