



ACTION PLAN 2010 - INSURANCE DIVISION

REVENUE

1. Augmenting Revenue Income and Revenue Recovery 20% to previous year.
2. Settlement of pending Court cases of more than 10 years in various courts.
3. Disposal of references received from field offices and other within 30 days / 45 days period respectively.
4. Finalization of panel of Advocates for Revenue cases.
5. Amnesty Scheme for settlement of pending irrecoverable dues of more than 10 years old.
6. Preparation of Revenue Manual and updation of Recovery Manual.

P&D

1. Extension of Scheme to newly implemented Centres numbering 50 in various Regions to cover 80,000 additional employees.
2. Enhancement of Wage ceiling for coverage of employees.
3. Amendment of ESI Act.
