Subject:- **Regarding participation of teams in ESIC Central Sports Meets.**

Sir,

I am directed to inform you that the representation from various field units have been received with regard to participation of players in the central sports meet sent on diversion/transferred to other region/sports zone and to clarify as under :-

1. In the event of **individual discipline** (except team events), if an employee has been transferred to another region/zone , no replacement would be made against the individual by the concerned region where from he/she qualified. In that case the individual who was winner or runners-ups in the individual event, he/she should participate in that event from the Zone where from he qualified. He will claim TA/DA from the present region & also practice in the posted region only.

However in case of retirement/resignation, no substitute as well as the retired/resigned employee in the individual events will be allowed.

Fixture in this regard will be made accordingly by the hosting region.

However, In the event of **team discipline**, replacement can be made by the concerned RO/SRO to the prescribed limit of the team(without disturbing the earlier team to the extent possible).

2. In case of individuals who were on **diversion/rotational transfer & transferee back to the parent region or diverted/transferred on rotational basis to SROs and vice- versa within the region** , such players/employees may be allowed to participate in the Central Sports Meet only from their

respective office from where they actually participated in the Zonal games and qualified for the same. This condition applies for both individual as well as team event. However, they can claim TA/DA from the participating region and also practice in the present posted region.
