Further, the cases of the officials holding higher posts on purely adhoc basis before the date of recommendation of financial upgradation, if any, may be regulated as per point No. 26 of Annexure-I of DOPT OM dated 19-05-09.

Their pay on up gradation shall be fixed as per para 4, & 7 of annexure-I to the aforesaid O.M dated 19-05-2009. The Officer shall have the option for fixation of pay under FR 22(1)(a)(1) within one month from the date of issue of order. Before allowing the financial up gradation as per the details above, the R.D may verify the detail of officer concerned from the service records of the officer concerned. Discrepancy, if any, may be immediately brought to the notice of Hqrs. Office.
