**Office Order No. 166 of 2014**

The Competent Authority on the recommendations of the Screening Committee has approved/ordered **3<sup>rd</sup> Financial upgradation w.e.f. 24.02.2014 in PB-2 (Rs.9300-34800) with Grade Pay of Rs. 5400/-** to Sh. Mohd. Yousuf, P.S., ESI Corporation, Regional Office, A.P. who was appointed in the cadre of Stenographer in the ESI Corporation under the Modified Assured Career Progression Scheme in terms of Govt. of India, DOPT O.M No. 35034/3/2008-Estt.(D) dated 19-05-2009.

The above financial up gradation under the MACP Scheme shall, however, be subject to the terms and conditions mentioned in O.M dated 19-05-09 and clarifications issued from time to time by Establishment Branch-III, Hqrs. on the subject. Further, the cases of the officials holding higher posts on purely adhoc basis before the date of recommendation of financial upgradation, if any, may be regulated as per point No. 26 of Annexure-I of DOPT OM dated 19-05-09.

His pay on up gradation shall be fixed as per para 4, & 7 of annexure-I to the aforesaid O.M dated 19-05-2009. The Officer shall have the option for fixation of pay under FR 22(1)(a)(1) within one month from the date of issue of order. Before allowing the financial up gradation as per the details above, the Regional Director may verify the detail of officer concerned from the service records of the officer concerned. Discrepancy, if any, may be immediately brought to the notice of Hqrs. Office.
