Please refer to e-Circular NBG/SMEBU-POWERJYOTI/34/2012-13 dated 08/09/2012 regarding the modalities for collection of contributions of ESIC through current account (Power Jyoti-PUL). ESIC have now advised that there is a delay in credit of the amounts in respect of the instruments/challans dropped in drop boxes. This causes unnecessary embarrassment to the employers who have deposited the contributions in time. As such, they have requested that the instruments/challans for ESIC contributions be received at the counters against acknowledgement.

2. Accordingly, we advise that:

ESIC challans/instruments should invariably be receipted against acknowledgement and not dropped in drop boxes. Necessary notice may be displayed at the concerned branches.
