

- (i) Whether most of the Scheduled Tribes and the reserved category posts are lying vacant in the Government and semi-Government institutions, companies, establishment etc.;
- (ii) If so, the details thereof and the reasons therefor;
- (iii) The steps taken by the Government to improve the situation during the last five years and the current year; and
- (iv) Total number of cases reported during the said period where vacancies reserved for such reserved categories including Scheduled Tribes were filled up with general category candidates.

2. It is requested that requisite information may be provided at the earliest for fulfillment of Assurance.
