
A Working Group has been constituted under the chairmanship of Shri A.K. Sinha, Additional Secretary, Ministry of Labour & Employment to develop a Web Portal in the Ministry for integrating the Reporting, Inspection and Grievance Redressal system under various Acts, being administered by the Ministry of Labour & Employment vide their Order No.Z-20025/06/2013-CLSI-I dated 19-11-2013.

Financial Commissioner, ESIC is one of the members of constituted Working Group for the matters related to ESI Corporation.

In the meeting of the Working Group held on 13-12-2013 in the Ministry, the Secretary (L&E) assigned responsibilities to the Bureau Heads who are in charge of different Groupings. Nodal Officers (one Senior and one junior) for each Act are also to be nominated. Every Bureau Head was advised to intimate the Name, Telephone number of the Nodal Officers to the Convener by 17th December, 2013.

Accordingly, the Director General has nominated Shri Arun Kumar, Additional Commissioner (Revenue) and Shri Sanjay Sinha, Director (ICT) as Nodal Officers for ESI Act to work under the overall guidance of Financial Commissioner for the said purpose. Financial Commissioner ESIC shall coordinate with the Responsibility Centre (Additional Secretary (L&E) for setting up a dedicated Web Portal (Reporting, Inspection and Grievance Redressal) for effective implementation of the ESI Act.
