OFFICE ORDER NO. 556 OF 2014


Pursuant to the recommendations of the Review DPC which met on 18th November, 2014, the Director General has ordered the placement of the following Medical Officers working as CMO (NMSG) of GDMO sub-cadre in the Senior Administrative Grade in PB-4 with Grade pay of Rs. 10,000/- under DACP scheme :-

2. In the event of a Medical Officer who is placed in the higher scale being on regular leave / study leave / deputation / foreign assignment etc. on the date of placement, the placement shall take effect from the date she/he had assumed charge.
3. The controlling officers may please ensure that even after excluding the period of EOL availed, other than on Medical Grounds by any of the Promoted Officer he/she should have completed 20 years of regular service as on approved date of promotion while allowing higher scale.
4. The pay of the above officials on promotion shall be fixed under Rule 13(1) of Revised pay Rules, 2008 and they will have the option, to be exercised within one month from the date of issue of this order, for fixation of their pay in the new post with effect from the date of placement to the new post or with effect from the date of increment in the old post.
5. The promotion will be subject to such terms and conditions as laid down in ESI Corporation (Staff & Conditions of Service) Regulations, 1959, as amended from time to time.
