I am directed to inform you that agreement with tie-up hospitals for various treatment procedures is to be done as per CGHS package rates, terms and conditions. In case of non availability of rates for procedures/items in CGHS, AIIMS rates are applicable. Since CGHS rates for ICD/CRT are not currently available in CGHS package rates, payment to tie-up hospitals may not exceed AIIMS rates as mentioned below:-

1	Implantable Cardioverter defibrillator (ICD) Single chamber	1,75,786.00
2	Implantable Cardioverter defibrillator (ICD) Double chamber	4,25,000.00
3	CRT-P (Cardiac Resynchronization therapy device with pacing)	1,95,000.00
4	CRT-D (Cardiac Resynchronization therapy device with defibrillator)	4,90,000.00
