Dear Mr Kumar,

As you are aware, the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 casts responsibilities on the appropriate Governments to take measures for empowerment of persons with disabilities (PwDs). As per section 33 of the said Act, every appropriate Government shall appoint in every establishment such percentage of vacancies not less than three percent for persons or class of persons with disabilities of which one percent each shall be reserved for persons suffering from (i) blindness or low vision; (ii) hearing impairment; (iii) locomotor disability or cerebral palsy in the posts identified for each disability. The list of posts identified to be reserved for PwDs has also been notified by this Ministry on 29.7.2013, which is also available in its website. However, the list is not exhaustive, individual Ministry/Department can supplement the list based on their requirement.

2. The Department related Parliamentary Standing Committee on Social Justice and Empowerment has observed that a number of posts meant to be filled by PwDs are lying vacant in various Ministries/Departments. The Committee specifically desires to know the precise number of vacancies and the posts reserved for the percentage it constitutes to total vacancies in the Central Government/State Governments/UTs.

3. I would request you to kindly arrange to provide the requisite information as desired by the Committee (as per the enclosed proforma) to DoPT as well as to us on half yearly basis by 31st October and 30th April every year. The information should also include the position in respect of public sector undertakings/autonomous bodies under the administrative control of your Ministry/Department.

4. I would also request you to take steps to identify posts for PwDs, if not yet identified and arrange for special recruitment drive to fill up the vacancies meant for PwDs on priority basis. Action taken in this regard may kindly be intimated to us urgently.
