MEMORANDUM


Sub: Fixation of Pay in respect of Directly Recruited Insurance Inspectors appointed on or after 01-01-2006 – reg.

A large number of references have been received from the Regions seeking clarifications on the fixation of Pay in respect of Directly Recruited Insurance Inspectors appointed on or after 01-01-2006. This issue was examined as per the CCS (Revised Pay) Rules, 2008 and the fixation of pay in respect of Directly Recruited Insurance Inspectors appointed on or after 01-01-2006 should be done in the following manner:-

1. Since in the ESI Corporation the Insurance Inspectors were granted the grade pay of ₹4600 notionally from 01-01-2006 and the monetary benefit granted from 01-10-2007, in the case of Directly Recruited insurance Inspectors appointed on or after 01-01-2006, their pay should be fixed notionally at 12,540 as pay in the pay band with grade pay of ₹4600.
2. However, simultaneously their actual pay should be fixed at 9,300 as pay in the pay band with grade pay of ₹4200.
3. On 01-10-2007 their notional pay will become their actual pay and from 01-10-2007 this will become their pay for all purposes.
4. In the case of Direct Recruits appointed as Insurance Inspector on or after 01-10-2007 their pay should be fixed directly at 12,540 as pay in the pay band with grade pay of ₹4600.
5. It is further clarified that fixation of pay as given above from Sl. No. 1 to 3 should be done, only in the case of Insurance Inspectors appointed on or after 01-01-2006 and before 01-10-2007.

This issues with the concurrence of Finance & Accounts.
