Sir,

I am directed to refer to your office letter No. U-13/14/38/08/Med.I-ESIC/SC dated the 5th January, 2009 on the subject mentioned above and to convey the approval of the Govt. with regard to admission policy in medical colleges to be opened by the ESI Corporation as follows:-

For Undergraduate/BDS Courses

- i) 40% State Quota
- ii) 20% to be reserved for ESI Stakeholders (10% for wards of Insured Persons, 5% for wards of Employers and 5% for wards of staff working in ESI Corporation/Scheme); and
- iii) 40% All India Basis

For Postgraduate Courses

- (i) 40% State Quota
- (ii) 20% to be reserved for ESI doctors working in ESI Corporation/ESI Hospitals; and
- (iii) 40% All India basis

It is therefore requested that further action in the matter may be taken accordingly under intimation to this Ministry.
