Sir,

I am directed to refer to your letter no. L-11/12/3/2007 dated 31.03.2010 on the above noted subject and to say that as per the judgement passed by Hon'ble Supreme Court of India in (2003) 11 SCC 146 in **Sourav Chaudhary** case, **50%** P.G. seats from the total number of seats without any exclusion should be contributed towards All India Quota by the participating Medical College and these seats should be filled up on all-India basis. Therefore the decision of Ministry of Labour & Employment to contribute 40% seats for All India Quota + 20% **only for ESI** doctors towards all-India Quota is against the said judgement.

You are, therefore, requested contribute 50% of total number of seats to All India Quota and rest 50% seats may be filled up by State Quota candidates.

So far as the reserving 20% of total number of seats for ESI doctors are concerned, you are requested to fill the same from state quota.

In view of the above, you are requested to kindly send the revised vacancy to all India Quota-2010 of ESI PGIMSR, Bangalore as per proforma enclosed at the earliest and do the necessary correction in letter no. U-16025/1/2008-SSI dated 29.01.2010.
