**MEMORANDUM**

**Sub: Procedure for admission to ESI Post Graduate Institutes of Medical Sciences & Research, (ESI-PGIMSR) for academic session 2010-11-reg.**

I am directed to invite reference to this office letter of dated 15-2-2010 on the captioned subject and to state that it has been decided to fill up the P.G. seats under the said admission policy in the following manner:-

1. The Central Government i.e. Ministry of Health and Family Welfare will select candidates for MD/MS and Diploma Courses against 40% All India seats & 20% seats reserved for Doctors working in the ESIC/ESI Scheme.
2. The State Government i.e. the concerned State/affiliated University will select candidates against the 40% seats of State Quota.

For filling up the seats for P.G. Courses the rule of reservation will be applicable as under :-

- A. Central Reservation Policy shall apply to the 40% All India seats and 20% seats reserved for ESI stake holders.
- B. State Government reservation policy shall be applicable for filling up of 40% seats of State quota.

Further for 20% seats reserved for ESI Doctors, only those who have appeared in All India P.G. Entrance Examination -2010 , will be considered, provided, a certificate of regular employment in ESIC/ESI Scheme from the competent authority along with NOC is produced at the time of counseling .

Study leave or leave of kind due for study purposes will have to be applied for by the selected candidates (working with ESIC/ESI Scheme) as per existing rules applicable to Central/State Government for the purpose.
