OFFICE ORDER NO. 145 OF 2010

The Competent Authority is pleased to order the promotion of Shri R. Natarajan, Joint Director, R.O. Tamilnadu to the grade of Regional Director Gr. 'A'/Director in the Pay Band PB-3 Rs.15600-39100 with grade pay of Rs.7600/- on regular basis on the recommendations of the DPC/UPSC for the vacancy year 2008-09 and post him as Director I/c SRO Coimbatore.

The regular promotion of Shri R. Natarajan has been ordered w.e.f. 23.03.2010 i.e. the date of regular promotion of his next junior. The pay on regular promotion in pay band PB-3 Rs.15600-39100 with grade pay of Rs.7600 will be fixed as per the provisions of FR22(I)(a)(1). The pay on regular promotion will be fixed notionally w.e.f. 23.03.2010 but the actual monetary benefit on the promoted post will be admissible from the date of issue of this order. He shall exercise his option for fixation as per the saving clause under FR22(I)(a)(1) within one month from the date of issue of this order.

The seniority of Shri R. Natarajan in the cadre of Regional Director Gr. 'A'/Director will be fixed at Sl.No.3A in the recommended panel for the year 2008-09 of the DPC/UPSC held on 18.03.2010 below the name of Shri A. Jayavelu (Sl.No.3) and above the name of Shri R.K. Nayak (Sl.No.4).

The promotion order of Shri Natarajan will be subject to the final outcome of WP(C) No.6301 of 2001, WP(C)No.5433 of 2006 pending before the Hon'ble High Court of Delhi and WP No. 13374/2010 pending before Hon'ble High Court of Madras.

The officer will immediately take relief from the present post to take charge as Director I/c SRO Coimbatore.
