**Subject: Implementation of ESI Scheme in contiguous areas of implemented centers in Himachal Pradesh.**

Sir,

I am directed to refer your endorsement no. HP/14/S/11/14/2009-Genl.Survey/Coord dated 15/7/2010 on above cited subject vide which you have sent figures of one implemented Centre-Paonta Sahib only. In Himachal Pradesh there are other implemented centres like Barotiwalla, Baddi, Nalagarh, Kala Amb, Mehatpur, Parwanoo, Solan & Shimla also, but there is no mention of the survey and figures of contiguous areas of such other implemented centres. In this connection, you may refer to Hqrs. Letter No. 15/14/1/2010-P&D dated 8/6/2010 vide which all Regional Directors were advised to complete the surveys of contiguous areas of all implemented centers by 30/9/2010 and submit the proposals to the concerned State Governments by 31<sup>st</sup> October, 2010. Proposals in installments as forwarded by you will result into issue of a number of notifications u/s 1(3).

(2) In view of above position you are advised as below:-

(a) Firstly, complete the survey of contiguous areas of all implemented centres in your State and submit the proposal to the State Government in a consolidated form in respect of all such areas found fit for implementation under intimation to Hqrs. Office. In the proposal you may invariably mention following aspects:-

(i) That these areas are within a radius of 8 KMs of the existing ESI Dispensary and no separate medical arrangements are required. You may also indicate the name of dispensary in respect of each such

contiguous area by adding one column of "Name of ESI Dispensary" in the proforma already mentioned in Hqrs. Office letter dated 8/6/2010.

- (ii) The name of Branch Office may also be indicated.
- (b) Submit draft notifications to be issued by the Central Government u/s 1(3) both in English as well as in Hindi as per procedure.
- (c) You may also confirm that the surveys of contiguous areas of all implemented centres have been conducted and no such area has been left out.

This issues with the approval of Insurance Commissioner.
