Assistant Engineers (Civil)</b></p> <p><b>Eligibility conditions :-</b> Officers under the Central/ State Govt./Union Territories/ Public Sector undertakings/Autonomous Bodies: -</p> <p>(a) (i) Holding Analogous post on regular basis; <b>or</b> (ii) with three years regular service in posts in the scale of Rs. 1640-2900/- (Revised: PB-2 Rs.9300-34800+Grade Pay Rs. 4200) <b>or</b> equivalent, <b>OR</b> (iii) with eight years regular service in posts in the scale of Rs. 1400-2300/ 2600/- (Revised: PB-1 Rs. 5200-20200+Grade Pay Rs. 2800/PB-2 Rs.9300-34800+Grade Pay Rs. 4200) <b>or</b> equivalent <b>AND</b></p> <p>(b) Possessing the following essential educational qualifications and experience :- (i) Degree in Civil Engineering from a recognised University or equivalent (ii) 2 years professional experience.</p> <p><b>Note:-</b> Only Central / State Govts./ U.T.s Officers will be eligible for absorption on transfer</p> <p>(Period of deputation, including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/ Department of the Central Govt., shall ordinarily not to exceed three years).</p>

Qualifications are relaxable are at the discretion of the UPSC in case of candidates otherwise well qualified.

The qualification(s) regarding experience is/are relaxable at the discretion of U.P.S.C in case of sufficient No. of candidates belonging to SC/ST community are not available.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationaists shall not be eligible for consideration for appointment by promotion. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications).
