- (b) Degree/ Diploma Certificate and other certificates, mark sheets of the examination passed, Attempt Certificate (if any) in support of your educational qualifications.
- (c) Certificate (as applicable) of having completed the compulsory rotating internship and valid certificate of registration / enrolment with the Medical Council of India/ State Medical Council / Dental Council of India / Central Register of Indian Medicine or State Register of Indian Medicine.
- (d) SC/ST/OBC certificates in the prescribed proforma issued by the competent authority by candidates claiming appointment against reserved posts. Candidates claiming reservation against posts reserved for OBC are required to produce the community certificate in the form Annexure-“A” prescribed vide Govt. of India DOP & T Memo. No. 36033/3/2004 EST- (Res.) dated 09-03-2004. The OBC certificate should have been issued in the last one year with certificate regarding creamy layer. If this certificate is not produced at the time of interview in original, then they will be not considered against OBC vacancies but will be considered against unreserved vacancies if otherwise eligible. If this certificate is not produced at the time of interview in original, the candidates will not be allowed to appear in the interview. P.H. candidates should submit P.H. certificate issued by a Medical Board duly constituted by State Govt./ Central Govt.

(e) All certificates/ documents in support of experience mentioned in the application, if any.

(f) The candidates who have submitted advance application must submit the proof of submission of application to their Department for onward submission to ESIC Office. Such candidates are otherwise required to produce a “No Objection Certificate” from the present employer at the time of interview, failing which they will not be interviewed.

Since, the original certificates are required to be verified, you are requested to bring all the original mark sheets/ certificates failing which you may not be interviewed.

No travelling allowance will be paid for attending the interview. However, those SC/ST candidates who are not employed anywhere will be entitled to reimbursement of travelling expenses limited to 2nd Class Mail/Express Rail Fare for both ways by the shortest route for attending the said interview, subject to their being found eligible for the interview and subject to quoting railway ticket number/ production of tickets.

The mere fact that you have been called for interview by the Corporation does not in any way guarantee that you will be selected. In case you are selected for appointment, your initial pay, if you are already in service in Central Government / ESIC, will be fixed in accordance with the relevant rules on the subject.
