Candidates will not be allowed to appear in the Part-II examination (Computer Skill Test) without Admit Card, attested copies of testimonials / documents in support of their age, educational qualification, NOC, if in Govt. Service, Certificates in support of Reserved Category / Sub Category in the prescribed proforma of Govt. of India and as per physical requirements in case of PWD as sub category for the post of UDC etc at the time of Part – II examination and any other documents mentioned in the general instructions. Prescribed proforma of Govt. of India has been uploaded in the website as Annexure “A”, “B” & “C”.

In case of any difficulty, the candidates may contact Regional Office, ESI Corporation, Sai Road, Phase I Housing Board Baddi, Himachal Pradesh in person or phone/fax/e-mail on any working day between 10.00 A.M. to 5.00P.M.

NOTE :

1. Candidates are advised to make himself / herself available as per reporting time

mentioned in the admit card.

2. Ex-Servicemen candidates who will be retired / discharged before 23.01.2013 i.e. within one year from the closing date of online registration will only be considered. They should also bring attested copy of Discharge Certificate issued by the Competent Authority showing inter alia, date of entry and date of discharge.
3. Candidates who did not mention medium for Computer Skill Test on the online application, will be treated as opted for English Medium.
