1. The selection of students for the year 2015-16 in ESIC run Medical Colleges is subject to the result of the WP 12953 of 2015, filed by M. Muthuvel and Others Vs Union of India & Others in the High Court of Judicature at Madras.
2. Candidates must bring
 - ◆ **Following certificates in original** at the time of counselling:
 - a. **Secondary School Certificate which must bear Date of Birth**
 - b. **Senior Secondary School certificate (+2). Provisional if final has not been issued**
 - c. **Marks Sheet of Senior Secondary School Examination (Candidate to bring evidence regarding obtaining qualifying marks as per MCI regulations)**
 - d. **Admit card for AIPMT-2015**
 - e. **Score card (AIPMT-2015) with Rank Position i.e. All India Rank**
 - f. **'Ward of IP Certificate' from Competent Authority of ESIC.**
 - g. **SC/ST/OBC/PH Certificate from the 'Appropriate Authority' in the format as specified in the Admission Notice.**
 - h. **Affidavits in support of being unmarried in the prescribed format (Female candidates only) as under**
 - i. **By the candidate [Annexure – VIII of Admission Notice].**
 - ii. **By the IP [Annexure – IX of Admission Notice]**
 - ◆ Two sets of photocopies of the above said documents.
 - ◆ Two passport size photographs.
 - ◆ **Candidates must bring at the time of counselling, Demand Draft / Bankers Cheque for Rs. 24000/- drawn in favour of 'ESI Fund A/c No. 1'.**
3. During the counselling all the above certificates **are to be produced in original** failing which the candidature is liable to be rejected.
4. **Other document(s) as mentioned in the foot-note, against the serial No. of the respective candidates at Annexure-(I) are to be produced during counselling.**
