No fee for SC/ST and women candidates. The application fee is not refundable.
2. Late or incomplete applications will be rejected and no consultation will be entertained in this regard.
3. Medical Superintendent reserves the right to fill up or not fill up any post without assigning any reasons whatsoever.
4. After screening of the applications only eligible candidates will be called for interview.

6. Only staff from State/ Central Govt. ESIC/ Quasi Govt. / Municipal Body/ Defence are eligible.
7. Candidate must be below the age of 64 years as on 28.04.2012. The contract will be valid either up to the date when regular staff join duty or when the contract staff attains 65 years of age or one year from the date of appointment whichever is earlier.

Maximum remuneration will be Rs. 15000/- per month subject to the condition that pension plus remuneration should not exceed the last pay including the D.A drawn by the official at the time of recruitment.
