**A. Age Limit:** - Between 21 to 27 years (as on 31-01-2011). Upper age limit is relaxable for SC candidates up to 05 years, for OBC candidates up to 03 years. Upper age limit is also relaxable for ESIC employees, Govt. Servants, Physically Handicapped & Ex. Service Man as per rules.
