(i) Degree of a recognized university or equivalent.

(ii) Fellow of the Actuarial Society of India.

(ii) With five years' service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs.8000-13500(Revised Pay as per Sixth CPC PB-3 Rs. 15,600-39,100/ + Grade Pay Rs. 5,400/-) or equivalent in the parent cadre/department ;

and

(b) Possessing the following educational qualifications and experience:-

Essential :-

(i) Degree of a recognized university or equivalent.

(ii) Associateship in the Actuarial society of India.

(iii) Five years experience in actuarial work in a Government or Quasi Government or in an Insurance Organization.

Note: The Departmental Deputy Director (Actuarial) in the scale of pay of Rs.8000-13500 with five years regular service shall also be considered alongwith deputationists and in case he is selected for appointment to the post the same shall be deemed to have been filled by promotion.

(Period of deputation (ISTC) including period of deputation (ISTC) in another Ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed four years).

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationaists shall not be eligible for consideration for appointment by promotion.


The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding 56 years as on the closing date of receipt of applications.
