
***Promotion to be made only if vigilance clearance is accorded.**

Result in respect of Sh. A.V. Ramakrishna, Roll No. 21140009, Assistant, S.R.O., Vijaywada, Andhra Pradesh has been withheld as per Order dated 27.9.2013 of Hon'ble High Court of Andhra Pradesh in WP No. 27050 of 2013. Further, Merit Order of the above 51 candidates is provisional and subject to final outcome of the above Court Case.

The promotion of the above officials to the post of Social Security Officer will, however, be subject to their fulfillment of the eligibility criteria, vigilance clearance (from respective disciplinary authorities and Vigilance Branch, Hqrs.) etc., as required under the rules and further subject to the condition that they are not otherwise disqualified for promotion. Subject to this condition necessary Order for promotion of the above officials to the post of Social Security Officer may be issued by the Hqrs. Office/Appointing Authority under intimation to the Recruitment Division.

The candidates at Sl. No. 3-4, 6-8, 16-17, 31-33, 35-37 & 38-39 have secured equal marks. **Inter-se-seniority of these candidates may be fixed as per rules by the cadre controlling authority.**
