**Executive Engineer (Electrical)**

**Eligibility conditions : -**

Officers under the Central or State Government or Union Territories or Autonomous Bodies or Statutory Bodies or Public Sector Undertakings or Universities or Research Institutions:

- (A) (I) holding analogous posts on regular basis in the parent cadre or department; ***or***
- (II) with five years' service in the grade rendered after appointment thereto on a regular basis in posts in Pay Band -3 ( Rs.15600-39100) Grade Pay Rs.5400/- or equivalent; ***or***
- (III) with Seven years' service in the grade rendered after appointment thereto on a regular basis in posts in the Pay Band-2 (Rs.9300-34800) Grade Pay of Rs.4600/- or equivalent; ***AND***
- (b) Possessing B.E or B.Tech. degree in electrical engineering from a recognized University or equivalent.

**Note 1.** The departmental officers in the feeder grade who are in direct line of promotion will not be eligible for consideration for appointment on deputation (ISTC). Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

"Period of deputation (ISTC) including period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Government shall ordinarily not to exceed four years'. The maximum age limit for appointment by deputation (ISTC) shall not be exceeding 56 years', as on the closing date of the receipt of applications".



**Note 2** . For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 01.01.2006 (the date from which the revised pay structure based on the 6<sup>th</sup> Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the pay commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any up-gradation.

The terms and conditions of the appointment of officers selected on deputation basis will be regulated in accordance with the orders contained in Govt. of India, Ministry of Finance O.M. No. F.1(11)-E-III(B)/75 dated 07.11.75 read with Govt. of India, Ministry of Home Affairs, Department of Personnel & Administrative Reforms O.M. No. 2 /29/91-E:tt.(Pay-II) dated 05.01.94 as amended by O.M. dated 20.06.2006. Applications are invited from eligible and willing candidates who can get relieved by their controlling officer in the event of their selection through proper channel.
