- 1. That I understand that if I am granted admission to MBBS course at ESIC Medical College for the academic year 2014-15, the fees and bond amount being charged/prescribed presently is subject to revision of fee structure and Bond amount.**
- 2. That I understand that the tuition fee amount @ Rs. 24,000/- per annum to be paid at the time of admission is on provisional basis.**
3. That it has been explained to me that the fee structure is under revision and fees are likely to be increased.
4.
