### INSTRUCTIONS TO CANDIDATES

1. Candidates should bring the **following certificates in original** at the time of counseling
  - a. **Secondary School Certificate which must bear Date of Birth**
  - b. **Senior Secondary School certificate (+2). Provisional if final has not been issued**
  - c. **Marks Sheet of Senior Secondary School Examination (Candidate to bring evidence regarding obtaining qualifying marks as per MCI regulations)**
  - d. **Admit card for AIPMT-2014**
  - e. **Score card (AIPMT-2014) with Rank Position i.e. All India Rank**
  - f. **'Ward of IP Certificate' from Competent Authority.**
  - g. **SC/ST/OBC/PH Certificate from the 'Appropriate Authority' in the format as specified in the Admission Notice.**
  - h. **Revised Affidavit as per Annexure –V on Stamp paper of Rs. 50/-**
  - i. **Affidavits in support of being unmarried in the prescribed format (Female candidates only) as under**
    - i. **By the candidate [Annexure – IX].**
    - ii. **By the IP [Annexure – X]**
2. Two sets of photocopies of the above said documents.
3. Two passport size photographs.
4. During the counseling all above certificates are to be produced in original failing which the candidature is liable to be rejected.
5. If at any stage it is found that the candidate has submitted false information / fraudulent certificates or found ineligible, the candidature will stand cancelled.
