APPLICATION FEE & MODE OF PAYMENT: Application Fee of -Rs.100/- (Rupees One hundred only), payable by way of Demand Draft / Pay order, drawn in favor of ' **ESIC Fund A/C No.1**' shall have to be submitted at the time of scrutiny of original documents. Application form can be downloaded from our websites www.esickar.gov.in and www.esic.nic.in. The candidates are advised to be present at least 20 minutes in advance to the time of interview, to enable prior verification of the eligibility criteria for permitting to be interviewed.

Qualification/Eligibility- PG Degree or equivalent qualification after MBBS with a minimum of 3 years experience after PG Degree/ with a minimum of 5 years experience after PG Diploma in respective specialties.

AGE - Not exceeding 45 year of age (Relaxation in age for SC/ST. as per Govt. of India rules).

Reservation – As per Govt. of India rule as on date will be followed .

EMOLUMENTS. - The selected candidates will draw, Pay of Rs 18750/- ,plus Grade Pay of Rs 6600, plus DA, , HRA NPA and other allowances as applicable to Central Government servants of equivalent grade pay and as revised from time to time.

DATE OF WALK-IN INTERVIEW - Date of interview will be 03.09..2014. All the candidates should report in the office of the Medical Superintendent .ESIC Hospital, Peenya. Bangalore, as per the timing mentioned above.

Other Terms and Conditions-

1. The number of vacancies may be changed without any prior notice.2
2. No. TA/DA will be admissible either for the '**Walk- in- interview**' or for joining the post.
3. The Competent Authority reserves the right to fill up all or not to fill up any post.
4. Selected candidates will have no claim for regularization of the service in the hospital.
5. The tenure is for a maximum period of 1 years, or till the regular Specialists joins, which ever is earlier.
6. Hostel accommodation/quarters/uniform will not be provided.
7. The selected candidates' will have to join within 07 days from the date of receipt of the selection order.
9. The selected candidate will have to furnish the DD/Bankers Cheque for an amount of Rs.30,000/-(Rupees Thirty Thousand Only) drawn in favor of '**ESIC A/c No 1**' payable at Bangalore, towards security deposit.
10. The selection is subject to the candidates proving their medical fitness & verification of their Character & Antecedents.
11. Private practice is strictly not allowed as the selected candidates will be in receipt of Non Practicing allowance. If found guilty, suitable action as provided under the relevant rules shall be taken

13. In case regular candidates join, the appointment shall be terminated as per the condition of the contract.
