ESSENTIAL QUALIFICATIONS:

The applicant must possess minimum qualification as prescribed by Medical Council of India – Minimum Qualification for Teachers in Medical Institutions Regulations, 1998 (***Should possess the recognized post-graduate medical qualification and other academic qualification from a recognized institution with a:-***

- (i) ***Fourteen years of teaching and/or research experience in a recognised institution in the speciality concerned or subject after obtaining the qualifying degree of Doctor of Medicine or Master of Surgery or qualification equivalent thereof.***
- (ii) ***Minimum of 10 years teaching experience as Professor / Associate Professor / Reader in a Medical College / Instt. out of which at least 05 years should be as Professor in a department. Preference for these appointments may be given to the heads of the Department)*** and MCI PG Medical Education Regulation, 2000 and its amendment 2005-06 (refer www.mciindia.org for detailed information).

PAY & ALLOWANCES:

1. ESIC has adopted Sixth Central Pay Commission. Basic pay and other allowances shall be paid as admissible.
2. The retired Government Officers shall be paid emoluments in accordance with the rule in force as on date.
3. Other candidates appointed on contractual basis will be paid Basic Pay at the initial stage i.e. initial Basic Pay of the relevant Pay Scale and other allowances as per rules of the Corporation .
4. Pay as on date (Basic Pay + Grade Pay + NPA @ 25%) at initial stage for other candidates is as under.

10. The candidates have to enclose the attested copies of all the relevant certificates/testimonials i.e. educational qualification, teaching experience, Pension Payment Order (PPO) etc.
