In addition, the candidates who have been selected under “Reserved Category” quota will have to satisfy their candidature in the appropriate category by producing original Certificates from Competent Authority regarding their caste status which will be got verified from the Competent Authority/ Issuing Authority. Caste certificates must be issued from Competent Authority for the purpose, in the prescribed proforma as per Govt. Of India instruction on the subject.

Candidates under “OBC” quota will have to satisfy that they not only belong to “OBC” as per “Central List of Other Backward Classes” in the states to which they belong but also they do not come from Creamy Layer as per DOP&T manual/ instructions. Both these certificates must be issued by the Competent Authority for the purpose, in prescribed proforma.

Candidates under PH quota will in addition, have to produce medical certificate from the Competent Medical Board constituted as per Govt. Of India instructions in the matter and in the prescribed proforma.

Candidates under Ex-Service Man (ESM) category will have to produce discharge certificate to prove their eligibility.
