AUCTION NOTICE

Public auction of a 1992 Model Maruti Gypsy No. DL-3CC-2044, having covered 1,77,270 Kms will be held on 'as is where is basis' in Golden Jubilee Hall of ESI Hospital, Okhla Ph-I, New Delhi on 26/04/2011 at 11.00 AM. The vehicle will be released to the highest bidder after depositing the entire amount on the spot. Interested parties may inspect the vehicle which is parked in the Campus of ESI Hospital, Okhla Ph-I, New Delhi-20 before the commencement of the auction.

- 1 All the bidders will be required to deposit security money of Rs. 3,500/- in the form of Demand Draft in favour of "ESI Fund Account No. 1" before the commencement of the auction.
- 2 The successful bidder have to pay the entire amount immediately and not later than 2 PM of 27/04/2011 failing which he/she shall forfeit his/her claim and security amount deposited by him/her shall also stand forfeited.
- 3 The successful bidder shall be required to remove the auctioned vehicle immediately and not later than 24 hours after its release by the Hospital Administration failing which a penalty @ 100/- per day will be charged and the vehicle will be at the risk and responsibility of the successful bidder .
- 4 All rights of the auction are reserved with the Medical Superintendent, ESI Hospital, Okhla Ph-I, New Delhi which includes the right to reject highest bid without assigning any reason thereof.
- 5 The highest bidder shall be required to get the vehicle registered with the transport authority at his/her own costs and expenses. The vehicle shall remain at bidder's risk as soon as auction sale is over, and he/she shall be absolutely responsible for the same.
- 6 On payment of the entire amount, the Competent Officer of ESI Hospital, Okhla shall sign all the relevant documents of transfer/sale and thereafter the highest awarded bidder shall have the absolute right to take possession of the said vehicle with all consequential responsibilities and liabilities including that of Motor Vehicle Act, 1988 and the Rules made thereunder.
- 7 **The employees of ESIC will not be eligible to participate in the auction.**
